In line with the overarching vision, AfricaLics supports African countries in developing and utilizing high-quality research, conducted by African researchers, to enable more informed policy decisions to be made relating to the use of and innovation (STI) science, echnology, for economic and social development as well as efficient governance. The network works closely with like-minded relevant international and local researchers and research networks to realize this vision.

The AfricaLics Secretariat is based at the African Centre for Technology Studies (ACTS), in Nairobi, Kenya and provides general support to the network and the AfricaLics Scientific Board (ASB).

Since its establishment, the network has received substantial support from the Swedish International Development Cooperation Agency (Sida) through the research capacity building (RCB) Programme entitled "Enhancing research capacity on Innovation and development (I&D) in Africa"

In addition, many universities in Africa and abroad have supported the network by housing key events (notably the research conferences, PhD academies and the Visiting Fellowship Programme), providing mentorship for young scholars, reviewing papers and applications for events, and providing lectures free of charge.



KEY NEWS HIGHLIGHTS

Africalics International Conference 2024

13th- 15thNovember 2024

Theme: The Africa We Want: Leveraging Innovation and Digital Transformation

Venue: University of Illorin, Nigeria

The 6th AfricaLics conference took place in Ilorin, Nigeria and had a special focus on leveraging innovation and digital transformation. It served as a platform for discussion of relevant research and action-oriented initiatives aimed at charting a course for Africa's future growth and prosperity in a sustainable manner.

A total of 223 papers were submitted, of which 81 were accepted. Among these, 38 papers were presented in paper presentation sessions, and 13 were showcased as posters. Most paper presentation sessions, along with the poster session, featured engaging papers and facilitated valuable discussions.

The keynote sessions brought together leading experts to explore critical themes at the intersection of technology, sustainability, and digital transformation in Africa and beyond.

• Prof. Geci Karuri-Sebina

Session Title: Seeing Like the Market: Unmasking the Politics of AI and Data-Driven Economies in Africa

Prof. Geci explored the political implications of artificial intelligence and data economies, particularly within African markets, revealing the challenges and opportunities of data-driven transformations.

Session Title: Technological Innovation and Digital Economic Transformation for Sustainable Development in Africa: Opportunities and Challenges

Prof. Siyanbola addressed the role of technological innovations in driving sustainable development in Africa, highlighting both the opportunities and challenges faced in achieving digital economic transformation.

Session Title: The Green and Digital Transformations: Are There Windows of Opportunity? Prof. Lema discussed the interplay between green and digital transformations, focusing on identifying opportunities to foster sustainable growth and innovation.

STRENGTHENING ACADEMIC COLLABORATIONS: THE 2024 AFRICALICS PHD VISITING FELLOWS WORKSHOP

The University of Johannesburg recently hosted the 2024 AfricaLics Visiting Fellows Programme (VFP), aimed at enhancing academic collaboration across Africa.

This initiative, part of the DSI-NRF Trilateral Research Chair in Transformative Innovation, the Fourth Industrial Revolution (4IR), and Sustainable Development, welcomed four PhD candidates from various African countries for a three-month mentorship and training program.

Running from September 1 to November 30, 2024, the workshop featured a week-long series of activities from September 16 to 20. These included structured courses on PhD supervision and mentoring, bilateral meetings, and a day dedicated to research presentations. The event was designed to foster collaboration among participants, allowing them to engage with peers, mentors, and supervisors while discussing key challenges in their research journeys.

Opening Remarks and Purpose

The workshop commenced with welcome speeches from Prof. Erika Kraemer Mbula of the University of Johannesburg and Dr. Ann Kingiri, Secretary General of AfricaLics. Prof. Mbula highlighted the importance of the trilateral chair in strengthening innovation systems in Africa through global partnerships. Dr. Kingiri traced the evolution of AfricaLics as a network dedicated to fostering research and capacity building in innovation studies across the continent. The primary goal of the seminar was to create an interactive platform for students and supervisors to discuss effective supervision practices, share challenges, and enhance the overall PhD experience.

Key Sessions and Discussions

The workshop included several focused sessions aimed at improving PhD supervision and mentorina:

- Students' Session: Participants shared their experiences with supervision, identifying challenges such as limited feedback and misaligned expectations. Strategies were discussed for fostering better communication with supervisors and developing independence in their research.
- Mentors & Home Supervisors Session: This session allowed supervisors to reflect on effective mentorship practices. Key points included the importance of constructive feedback, setting clear expectations, and creating an inclusive research environment that encourages open dialogue.
- Effective Planning and Prioritization: Participants learned about essential strategies for effective planning, deep work techniques, and prioritization skills necessary for academic suchess://AFRICALICS.ORG. @AFRICALICS. AUGUST,2024

- Feedback Strategies: The significance of timely and specific feedback was emphasized as crucial for nurturing students' independence and academic growth.
- Communication Strategies: Effective communication was identified as vital for productive relationships between students and supervisors. Key strategies included active listening, clear expression of ideas, and conflict resolution techniques.



Conclusion

The 2024 AfricaLics VFP workshop successfully brought together emerging scholars from across Africa to enhance their academic journeys through mentorship and collaborative learning. By addressing key challenges in PhD supervision and fostering open communication between students and supervisors, the program aims to strengthen research capabilities within the continent's academic landscape. This initiative not only promotes individual growth among PhD candidates but also contributes significantly to building a robust network of scholars dedicated to advancing innovation for sustainable development in Africa.

Bridging the Gap and Strengthening Connections Between Academia and Policymaking webinar held on 18th July 2024

Bridging the Gap and Strengthening Connections Between Academia and Policymaking

Date: 18th July 2024 **Speaker**:Prof. Rebecca Hanlin

Communicating research findings to policymakers is crucial for bridging the gap between academia and real-world impact. This webinar explored effective strategies, best practices, and case studies to bridge the gap between research outcomes and policymaking processes.

During the discussions, the speaker explored the importance of effective communication strategies in conveying complex research insights to policymakers.

The focus was on maximizing engagement, relevance, and actionable outcomes to influence policy agendas for meaningful societal impact. The webinar spoke on the valuable insights and how to enhance ones' ability to effectively communicate research to policymakers.

The discussion addressed the following questions:

- 1. What are some of the common challenges researchers face when communicating their findings to policymakers?
- 2. How can researchers ensure that their research findings are effectively communicated to policymakers in a way that resonates with their needs and priorities?
- 3.What role do interdisciplinary collaborations play in enhancing the communication of research findings to policymakers?
- 4. How can researchers leverage digital tools and platforms to enhance the reach and impact of their research on policymakers and the broader community?





Webinar Series: Sectoral systems of innovation. Learnings from South Africa

Date: 5th September 2024

Speaker: Professor Michael Kahn is a policy analyst and evaluator in the fields of research and innovation.

In this webinar Prof. Khan examined the evolving nature of research and innovation policy and associated outcomes in South Africa. It critiqued research and innovation policy starting at the micro level of the firm, through to the aggregate level of STI indicators.

Prof Khan used case studies to elicit the nature and origins of four innovations locating these in their respective sectoral systems according to the Malerba (2002) formulation. SSIs advance the much earlier work of Marshall (Rosenthal and Strange, 2004) with a more nuanced understanding of innovation, focusing on specific sectors, incorporating actors beyond the firm, the dynamics and trajectories of knowledge flows and institutions in shaping innovation processes.

Each case started with a concise PESTE analysis followed with bibliometric analysis and publication co-authorship, and patent statistics including patent awards in multiple urisdictions, the use of government incentives and the management of intellectual property.

All cases demonstrated high levels of path dependence on the part of one or more of the primary actors. Selection bias acknowledged, none of the cases arised from the direct intents of STI policy. The cases spoke to industry needs rather than government push.

THEME

Paradigm transition, geopolitics and innovation paths: Challenges and Opportunities for Africa



Webinar Series -Paradigm transition, geopolitics and innovation paths: Challenges and Opportunities for Africa **Date**: 6th November 2024 **Speaker**: Raphael Kaplinsky is Honorary Professor at the Science Policy Research Unit, and is also an Emeritus Professor at the Institute of Development Studies and at the Open University.

Policy is generally pursued with temporal blinkers – What can we do to build on what we already have and does not require too great a reframing? In 'normal times' building on the past, adjusting and speeding up, makes sense. But occasionally the world around us changes in non-marginal ways and this demands a structural reset to policy in general and to innovation trajectories in particular.

Prof Kaplinsky noted that we are in just such a transitional period now. The mass-production technoeconomic paradigm which dominated development strategies over the past 70 years is in crisis. The new ICT paradigm is deploying rapidly. Because it offers both threat and opportunity, imparting directionality is the critical challenge.

Each techno-economic paradigm is not just characterised by its core general-purpose 'heartland' technology and the accompanying socio-economic order. It also has associated geopolitics which play a major role in the character of global production and trade. So it is that we are witnessing a significant change in the global order, a transition from a unipolar world dominated by western powers to a world of multipolar hegemony, with China, India and other Asian economies playing increasingly important roles in framing directionality and innovation paths.

Prof Kaplinsky concluded with a question to the audience: In this context, what are the implications for more sustainable and equitable growth strategies in Africa?
